# TRENCH TRAINING

**EMERGENCY RESPONSE TEAM & SC TASK FORCE 6** 









"You never know when something bad is going to happen," said Jessica Stumpf, Director of Greenville County Emergency Management. "They are in the hole, they are trying to stabilize the trench in order to rescue or recover someone who may be trapped down there."

Task force leaders said one cubic yard of dirt can weigh anywhere between 75-100 lbs. If you are trapped underneath, crews are not only working on the safety aspect of their recovery operation but also racing against the clock.





#### PER-211

This course provides a strong emphasis in developing a multi-discipline, whole-community team approach to planning, preparing, responding, managing and recovering from an event involving CBRNE agents, a coordinated complex terrorist attack (CCTA), an active shooter or other violent event. To reinforce this multi-discipline team approach, participants should optimally be from fire services, law enforcement, Emergency Medical Services (EMS)/hospital, public health, public works, and emergency management organizations.

#### **Topics**

- · Identifying threats and hazards in a hazardous/active threat environment.
- Using the RAPID-Care algorithm when responding to a hazardous/active threat environment.
- Personal protective equipment (PPE) and protective measures for the hazardous/active threat environment.
- Recognizing casualties exposed to a CBRNE agent.
- Decontamination considerations and treatment for casualties exposed to a CBRNE
- Triage and medical management of casualties during a CBRNE, Active Shooter or
